The Richlands' Board of Alderman met for a Special Call Meeting on Thursday, June 07, 2012 at 4:00 pm at the Richlands Town Hall. The purpose of the meeting was to present the Proposed FY 2012/2013 Budget to the Board and for the Board to schedule a Public Hearing for the Proposed FY 2012/2013 Budget.

MEETING CALLED TO ORDER:

Mayor McKinley Smith called the meeting to order at 4:05 pm.

PRESENTATION OF THE PROPOSED 2012/2013 FY BUDGET:

Gregg Whitehead, Town Administrator presented to the Board the Proposed 2012/2013 Fiscal Year Budget to the Board. Mr. Whitehead stated that the Board will need to schedule a public hearing and the budget must be adopted prior to July 1, 2012. Mr. Whitehead noted the only change on the fee schedule is the rental fees for the Community Building. The new proposed rental fee for the Community Building is \$250.00 per day from 8:00 am to 11:30 pm with a \$100.00 deposit. The Town Hall Board Room may also be rented for 3 hours at a fee of \$30.00. No food will be permitted in the Board Room. The new rental policy will be presented at the next Regular Board of Aldermen meeting on June 12, 2012. The proposed budget also includes the addition of one full time police officer and the replacement of one police vehicle and one public works vehicle.

A copy of the Proposed FY 2012/2013 Budget is available for public viewing in the Town Clerk's Office.

A motion was made by Alderman Tom Brown, seconded by Alderman Kandy Koonce to schedule a public hearing on Tuesday, June 26, 2012 beginning at 6:00 pm at the Richlands Town Hall for the purpose of hearing public comment on the Proposed FY 2012/2013 Budget Ordinance, also to adopt the Proposed FY 2012/2013 Budget Ordinance and to approve any end of current year budget amendments that are needed. The motion was unanimously carried.

ADJOURN:

With no further business, a **motion** was made by Alderman Tom Brown, seconded by Alderman Paul Conner to adjourn the meeting at 4:11 pm. The motion was unanimously carried.
